Summary: Experimental Health Care Treatment Law

AN ACT TO AMEND THE CODE OF LAWS OF SOUTH CAROLINA, 1976, TO ENACT THE "THE RIGHT TO TRY ACT" BY ADDING CHAPTER 137 TO TITLE 44 SO AS TO GIVE CERTAIN PATIENTS WITH A TERMINAL ILLNESS THE RIGHT TO TRY AN INVESTIGATIONAL DRUG, BIOLOGICAL PRODUCT, OR DEVICE TO TREAT THE ILLNESS; TO PROVIDE PROTECTION FROM LIABILITY FOR ENTITIES PROVIDING CARE FOR A PATIENT USING AN INVESTIGATIONAL DRUG, BIOLOGICAL PRODUCT, OR DEVICE AND FOR MANUFACTURERS OF THESE DRUGS, BIOLOGICS, AND DEVICES; TO PROTECT CERTAIN HEALTH CARE PROVIDERS AND ENTITIES FROM PROFESSIONAL DISCIPLINE OR OTHER SANCTIONS FOR RECOMMENDING AN INVESTIGATIONAL DRUG, BIOLOGICAL PRODUCT, OR DEVICE; AND FOR OTHER PURPOSES. - ratified title
