A Bill to amend Section 59-20-40, as amended, Code of Laws of South Carolina, 1976, relating to the determination of allocations under the Education Finance Act, so as to provide for allocation for students in home schooling, and to amend Section 59-65-40, relating to instruction of students at home, so as to allow a parent or guardian to educate his child at home upon the approval of the home instruction by the school district board of trustees of the district in which the child resides, to provide the requirements that must be met for approval of a plan of home instruction, to provide for the application process and adequate notice, to provide for readiness testing of first grade students in home instruction, to provide for procedures when students enrolled in home instruction fall below promotion standards, and to provide for an application approval appeals procedure.-amended title
