A Bill to provide for the manner in which and single-member election districts from which members of the Board of Trustees of the School District of Greenville County must be elected beginning in 1992, to amend Section 7-7-280, as amended, Code of Laws of South Carolina, 1976, relating to voting precincts and voting places in Greenville County, so as to revise these precincts and voting places, and to repeal Act 544 of 1982, relating to the Board of Trustees of the Greenville County School District.-amended title
