AN ACT TO AMEND SECTION 59-1-425, AS AMENDED, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO THE OPENING DATE FOR THE PUBLIC SCHOOL YEAR, SO AS TO MAKE GRAMMATICAL CHANGES; AND TO AMEND SECTION 59-18-325, AS AMENDED, RELATING TO CERTAIN ASSESSMENTS OF VARIOUS PUBLIC SCHOOL STUDENTS BASED ON GRADE LEVEL, SO AS TO REVISE VARIOUS ASSESSMENTS USED, MANNER OF PROCUREMENT, IMPLEMENTATION, AND ADMINISTRATION OF THESE ASSESSMENTS, AMONG OTHER THINGS. - ratified title
