### **S\*0689 (Rat #0561, Act #0614 of 1990) Joint Resolution, By P.B. McLeod**

A Joint Resolution to create the Health Benefit Plan Demonstration Project to develop and test models for providing health insurance coverage to South Carolinians who currently are uninsured; create the Health Benefit Plan Demonstration Council and provide for it to assist and advise the Health and Human Services Finance Commission on the project; provide for the powers and duties of the Commission; exempt the project from Code provisions and regulations relating to insurance and funding; and provide for the project's termination.-amended title
