### **S\*0729 (Rat #0079, Act #0109 of 2021) General Bill, By Gustafson and McElveen**

#### **Summary:** Kershaw Health

AN ACT TO AMEND ACT 725 OF 1969, RELATING TO KERSHAW HEALTH, SO AS TO PROVIDE FOR THE COMPOSITION OF THE KERSHAW HEALTH BOARD OF DIRECTORS, THE MANNER OF NOMINATION AND APPOINTMENT TO THE BOARD, AND THE TERMS OF BOARD MEMBERS, AND TO REVISE THE PURPOSE AND SCOPE OF THE BOARD'S POWERS AND DUTIES; TO AMEND ACT 868 OF 1954, AS AMENDED, RELATING TO THE BOARD'S POWERS AND DUTIES, SO AS TO MAKE CONFORMING CHANGES; AND TO PROVIDE FOR THE APPOINTMENT OF A NEW BOARD OF DIRECTORS, AND TO STAGGER THE TERMS OF THE NEW BOARD OF DIRECTORS. - ratified title
