### **AGENCY'S DISCUSSION AND ANALYSIS**

#### I. AGENCY OVERVIEW OF FY 2023-2024 AND FUTURE PLANS

#### **Internal & External Factors Affecting Performance:**

The South Carolina Commission on Prosecution Coordination (SCCPC) continued to made progress in FY 24 towards addressing the agency's technology needs. Additionally, development of the agency's database project continued as the SCCPC's retained vendor continued development of a workflow automation tool for the collection and reporting of statewide prosecution data. Internal agency staff successfully implemented cloud-based data integration from circuit Case Management Systems to the SCCPC cloud database and has developed the first set of Power BI reports that will support automated reports using data pushed from solicitor case management systems to the SCCPC's database. Although great strides have been made, completion time of the database project is directly tied to the responsiveness and performance of the solicitors' case management system vendors and the agency's retained vendor responsible for development of an e-forms system. With state funding appropriated for staffing in the FY 23 state budget, the SCCPC hired an attorney in FY 24 to assist with legislative issues, legal research, special projects, and legal inquiries which has helped the SCCPC with sustaining and meeting increased demand for legal trainings, research, support, updates, and materials. The SCCPC has also fostered and supported career growth among staff by encouraging and enabling staff to pursue relevant educational and training opportunities, promoting individuals assuming additional responsibilities, and awarding salary increases to retain talent and experience. These efforts have beneficially affected staff performance by increasing moral, productivity and performance.

Technology funding appropriated in the FY 23 state budget for the Offices of Circuit Solicitor has been used by these offices for the replacement and upgrade of their case management systems, evidence management systems, increased data storage capability, basic and enhanced fiber connections and bandwidth to support internet connectivity, interface and integration connections with other systems, enhanced IT security, and other technology enhancements. While the non-recurring funding for technology has been instrumental in enabling the solicitors to purchase new case management systems or upgrade their existing systems, recurring technology funding is needed for the ongoing maintenance and support of the solicitors' case management systems and for the recurring costs associated with enhanced internet service, evidence management systems, cloud data storage, and IT support services.

State funding appropriated in the FY 24 state budget has enabled the Offices of Circuit Solicitor to hire additional attorneys and retain their existing talent. Now additional funding is needed for critical non-attorney prosecution team positions in solicitors' offices, including diversion program staff, victim/witness advocates, investigators, paralegals, IT staff and other administrative professionals.

Collectively, the recurring funding needed (and that will be requested for FY 26) for the operation of the Offices of Circuit Solicitor to maintain and support technology enhancements, retain experienced attorneys, and hire additional non-attorney staff is necessary so that the Circuit Solicitors can handle the increased workloads placed on their offices as the number of annual arrests continues to increase.

#### **Current Efforts and Plans under Development to Introduce Additional Changes:**

A primary focus of the SCCPC continues to be offering a diverse array of high-quality training and educational programing for the Offices of Circuit Solicitor as well as other prosecution and law

enforcement entities. The SCCPC offers both in-person and virtual trainings. Virtual trainings and meetings have enabled greater communication and coordination with the Offices of Circuit Solicitor and have promoted a more inclusive audience as many office staff who were previously unable to attend in-person meetings due to budgetary restrictions are now regularly attending virtual meetings held by the SCCPC. In FY 25, the SCCPC will be migrating to a new registration platform to better support the agency's education and training mission.

Another large focus for the SCCPC in FY 24 was developing, procuring, and implementing various technology initiatives, primarily the database project for the SCCPC, Case Management System (CMS) upgrades for the Offices of Circuit Solicitor, and interface between the SCCPC and Offices of Circuit Solicitor systems. The SCCPC has worked extensively with the sixteen Offices of Circuit Solicitor and their respective CMS to pull circuit solicitor reporting data in an automated manner. Rather than the Offices of Circuit Solicitor entering data into their respective CMS then reentering the same data in report templates for submission to the SCCPC, the process of reporting will be automated. The SCCPC will be able to pull data from the circuit CMS to the Azure government cloud housed with the SCCPC, where the data will then populate into the SCCPC database where the SCCPC will generate reports without the need for further manual entry. The automation of the circuits' data submission will provide numerous benefits for both the SCCPC and the Offices of Circuit Solicitor both in terms of efficiency and accuracy.

In FY 24, the SCCPC has continued its partnership with the South Carolina Department of Administration's Division of Technology Operations (DTO) to implement the database project. The SCCPC continues to use Microsoft Azure Government Cloud which is specifically built to meet state and federal government compliance and security requirements. The SCCPC implemented data integration between circuit case management systems and the SCCPC's cloud database utilizing Microsoft government cloud infrastructure and submission tools. This database currently accepts data from the circuit case management systems for two reports and the amount of data collected from the case management systems for reporting purposes will expand in FY 25.

In FY 24, the SCCPC also continued to work with its contracted partner, an entity on state contract responsible for the design and implementation of an e-forms documentation system for the SCCPC into FY 25. The existence of the e-forms allows for data pulled from the Offices of Circuit Solicitor CMS to prepopulate into the SCCPC database and will also allow the circuits web-based access to the database where they may also manually enter any data not already in the CMS. Testing of three e-forms was completed in June 2024. In FY 25, the SCCPC will finalize, test, and approve production deployment of the remaining e-forms reports that the third-party developer is currently developing.

The SCCPC also assisted the Offices of Circuit Solicitor with prosecutor recruitment and retention efforts. During FY 24, the SCCPC hosted an inaugural prosecution job fair that was attended by representatives from all sixteen solicitors' offices and the South Carolina Attorney General's Office to highlight the benefits of prosecution and public service. The SCCPC plans to host another prosecution job fair in FY 25. The SCCPC further supported the recruitment efforts of the Offices of the Circuit Solicitors by advertising open positions on the SCCPC's website, a task that will continue into FY 25. The SCCPC also aided the recruitment of prosecutors by highlighting other job fairs, including at local law schools and larger job fairs (such as the National District Attorneys Association's annual job fair). The SCCPC will continue to focus its efforts on the recruitment and retention of prosecutors into FY 25.

#### II. NOTABLE ACHIEVEMENTS AND RESULTS IN FY 2023-2024

The SCCPC achieved the following during FY 2023-24 in furtherance of the agency's mission:

- Exceeded training goals for FY 24 by offering 178.30 hours of continuing education opportunities through twenty-four (24) one-day or shorter trainings as well as the two-day Leadership Challenge program and two programs co-sponsored with the South Carolina Solicitors' Association, the four-day 2023 South Carolina Solicitors' Annual Conference and the five-day 2024 Prosecution Bootcamp (for these two programs, the Association covers the costs associated with the programs and the SCCPC plans and conducts the trainings). The 178.30 hours consisted of 100.80 hours for prosecutors and paralegals, 36.50 hours for Solicitors' investigators and other officers, and 27 hours for victim advocates. In addition to these accredited training hours, 14 additional hours of other educational opportunities were offered for Offices of the Circuit Solicitor staff members. While the Annual Conference, Bootcamp, and 13 other programs were conducted as in-person trainings, the others were conducted live using Zoom<sup>TM</sup> webinars. The trainings offered were on topics relevant to the duties of the staff of the Offices of Circuit Solicitor, including:
  - o the Constitutional Carry legislation;
  - o trial advocacy;
  - o evidentiary issues;
  - o appellate and post-conviction considerations for trial prosecutors;
  - o prosecution's disclosure obligation;
  - o offense-specific topics, including those related to driving under the influence, crimes against animals, and juvenile justice;
  - o victims' rights, advocacy, and restitution;
  - ethics and professionalism;
  - o technology;
  - o forensic science;
  - o legislation;
  - o Freedom of Information Act;
  - o mental health; and
  - o general law updates.
- Offered the "Case Round-Up" training program, a one-hour "lunch and learn" training program
  covering all criminal, quasi-criminal, and other decisions of interest to prosecutors, issued by the
  Supreme Court of the United States and South Carolina appellate courts during the preceding
  month, held on a monthly basis except for the month of the annual conference and for any month
  in which no or only a few monumental opinions were issued.
- Provided legal updates to the Offices of Circuit Solicitor, Attorney General, and municipal
  prosecutors registered with the SCCPC immediately upon the release of opinions and orders by
  the Supreme Court of the United States and South Carolina's appellate courts announcing a
  significant change to the substantive law, court procedure, or ethics rules.
- Provided notifications or summaries to the Offices of Circuit Solicitor, Attorney General, and municipal prosecutors registered with the SCCPC upon the enactment of relevant legislation by the South Carolina General Assembly.
- Provided weekly updates to the Offices of Circuit Solicitor on pending legislation, legislative
  action, and other relevant events of the South Carolina General Assembly during the legislative

session, as well a comprehensive report at the conclusion of the legislative session and special updates on specific legislation as needed. In FY 24, the SCCPC was able to increase the frequency and substance of these legislative updates to the Offices of Circuit Solicitor after hiring a Legislative Counsel, a senior attorney with experience in criminal law, to act as a dedicated liaison between the SCCPC and the General Assembly and timely communicate with the Offices of Circuit Solicitor regarding legislative matters.

- Expanded the training email alert to inform the Offices of Circuit Solicitor, Attorney General, and some municipal prosecutors and law enforcement officers (those registered for such notices) of training opportunities offered by the SCCPC and other organizations and providers (local, state, and national).
- Continued working with the Offices of Circuit Solicitor toward compliance with the orders issued by the U.S. District Court for the District of South Carolina in *Kenny v. Wilson*, which enjoined the prosecution of certain juveniles for one crime and required the expungement of convictions and adjudications of two sub-classes of juveniles for two crimes. The SCCPC collected information on the status of compliance from each Circuit Solicitor for compilation and submission to counsel for both parties.
- The SCCPC continued to use the Azure Government Cloud, including a Platform as a Service (PaaS) Azure SQL Database, which continues to be utilized to house the data pulled from the Offices of the Circuit Solicitor CMS. This cloud-based system currently accepts data on Driving Under the Influence (DUI) and Domestic Violence (DV) disposed cases. The SCCPC also designed Microsoft Azure SQL Database data structures and Azure cloud infrastructure for Pending Warrants, and Pre-trial Intervention (PTI)/Diversion reports, covering both pending and disposed cases for all CDR Statute Code offenses.
- Provided review, testing and sign off for production of DUI, Domestic Violence, and Pending Warrants reports within the e-forms system being developed by a third-party vendor.
- Developed a new agency website with added functionality and internal capability to upload, edit, and modify the website to better serve the Offices of Circuit Solicitor, the public, and other stakeholders.
- The SCCPC applied for, received and managed federal grant funds for the John R. Justice Student Loan Forgiveness Program (JRJ Program) to recognized South Carolina prosecutor and public defender applicants who have demonstrated a commitment to public service with an award to lessen the financial strain of existing student loan debt. The availability of the award and notice of the application process is announced statewide, through directed emails, distribution to the law schools, and publication by the South Carolina Bar and is available to prosecutors and public defenders statewide. The total amount of the award available is divided equally between the eligible prosecutor and public defender applicants; if more of one type of applicant applies than the other, than the amount of the individual awards to the applicants in the smaller type of pool will be more than the applicants in the other pool receive. All eligible applicants received an award.
- The SCCPC continued to offer Zoom meetings for all diversion and treatment coordinators in the
  Offices of Circuit Solicitor, increasing the frequency of meetings to every two months from once
  a quarter, and offering special guest presentations.
- The SCCPC was awarded grant funds for a Traffic Safety Resource Prosecutor (TSRP). The grant is administered and allocated in South Carolina by the Department of Public Safety, Office of

Highway Safety and Justice Programs. Pursuant to grant requirements, the SCCPC conducts trainings for prosecutors, law enforcement, and summary court judges on traffic safety enforcement, prosecution, and adjudication, with a specific focus on DUI and traffic-related offenses.

- Provided technical legal support on ethics, constitutional law, evidentiary law, criminal law and procedure, trial, and appellate issues for the Offices of Circuit Solicitor. Over 100 requests for assistance were received and completed.
- Pursuant to state law, collected data from the Offices of Circuit Solicitor and prepared annual reports on:
  - o Expenditures and Revenue (state, local, federal, and non-governmental funding sources);
  - o Solicitor Diversion and Treatment Court Programs;
  - o Domestic Violence (DV) prosecutions;
  - o Driving Under the Influence (DUI) prosecutions.
  - o Court Fines and Fees;
  - o Victim Services; and
  - o Pending Warrants and Attorney Recruitment
- Responded to inquiries from and provided input to the South Carolina General Assembly on legislation, budget requests, and fiscal impacts. In FY 24, the SCCPC was able to increase this communication by onboarding a Legislative Counsel, a senior attorney with experience in criminal law, to act as a dedicated liaison between the SCCPC (and the Offices of the Circuit Solicitors) and the General Assembly regarding legislative matters.
- Served as a resource for and/or provided technical assistance to other local and state agencies on issues related to criminal justice.
- Three SCCPC staff members served as speakers and/or resources for local, state, and national organizations and/or government agencies related to criminal justice and prosecution training, including the South Carolina Bar, South Carolina Court Administration (two different trainings for summary court judges), and the National Association of Prosecution Coordinators.
- The SCCPC implemented a statewide Westlaw account for the benefit and use of Offices of Circuit Solicitor to provide improved, comprehensive legal research tools for prosecutors.
- Hosted a prosecution job fair that was attended by representatives from all sixteen solicitors'
  offices and the South Carolina Attorney General's Office to highlight the benefits of prosecution
  and public service.

#### III. DISCUSSION OF AGENCY PLANS FOR FY 25 AND BEYOND

An overview of plans the SCCPC has developed or that are under development is provided in Section I. A more detailed description of these plans, the continued efforts of the SCCPC, and the goals expected to be achieved through implementation of these planned initiatives and ongoing efforts follows:

## 1. <u>Develop, coordinate and conduct regular training and continuing education for Circuit Solicitors, prosecutors, and staff.</u>

Chief among the services the SCCPC provides for the Offices of Circuit Solicitor is regular training for all prosecution staff. Agency staff will continue to coordinate and conduct trainings in the future tailored to the needs of prosecutors, paralegals, investigators, victim advocates, diversion

program staff and administrative staff and will provide resource materials for every training that is conducted for future reference and use. The SCCPC staff also serves as a legal resource for and responds to regular requests for technical assistance from Solicitors and their staff on issues related to the prosecution function (including ethics, charging, evidence, constitutional, trial, expert witness, disposition, advocacy, and appellate); provides updates on legislation, case law, and government orders; and reviews pleadings upon request. Agency staff will continue to provide such technical assistance as requested.

The SCCPC conducts in-person and webinar trainings (via Zoom<sup>TM</sup>). The benefits afforded by webinars (including, for the staff of the Offices of Circuit Solicitor, easier access to training and less time away from the job because travel is not required) have resulted in webinars becoming a mainstay of the SCCPC's training curriculum.

In FY 25, the SCCPC will continue to develop and conduct its two biggest programs: the four-day South Carolina Solicitors' Annual Conference with approximately 700 attendees and the five-day Bootcamp program for new prosecutors. The Annual Conference brings together Solicitors and their staff, other state and local prosecutors, diversion program staff, prosecution investigators, paralegals, administrative staff, speakers, and guests from across the State for training and required legal education. The Bootcamp program brings together senior prosecutors and new lawyers in the Offices of Circuit Solicitor for the purpose of providing trial advocacy training. The SCCPC will continue to conduct the Prosecution Bootcamp program as a two-part training. Part I of the training, which was held in June 2024, is a five-day program with a greater focus on trial advocacy. Part II of the 2024 Prosecution Bootcamp, which will be held immediately prior to the annual conference, is a one-day training consisting of substantive law presentations focusing on basic criminal law and procedure.

The SCCPC will continue to obtain accreditation for its trainings from the Supreme Court of South Carolina's Commission on CLE and Specialization, South Carolina Criminal Justice Academy, and/or Department of Crime Victim Services Training, Provider Certification & Statistical Analysis. Evaluations will continue to be utilized to determine the effectiveness of each training.

In addition to accredited training programs, the SCCPC has offered and will continue to offer other educational programs for prosecution staff members who do not have formal continuing education requirements. The SCCPC will also continue to offer the opportunity for select groups of prosecution staff to address specific changes in the law, such as expungement personnel, family court prosecutors, DUI prosecutors, and Sex Offender Registry points of contact; this engagement will continue into FY 25 and beyond.

2. Continued development and implementation of an agency database. In FY 24, the SCCPC continued cloud development for its database project and reporting tools. Originally a grantfunded project, the SCCPC received non-recurring funding in FY 23 to continue and sustain the project, which will allow all forty-six counties of the sixteen judicial circuit solicitors' offices to conduct web-based reporting of prosecution data. In late 2022, the SCCPC contracted with a third party developer already on state contract, to build a web-based e-forms system to be used by the sixteen judicial circuits to securely transmit reporting data from the circuits' CMS to the SCCPC. The SCCPC and its contracted partner have continued to meet on a bi-weekly basis for most of FY 24 to discuss specifications of the e-forms and some of these forms were rolled out for use by the

circuits at the beginning of FY 25. For the remainder of the fiscal year, the SCCPC will work with the third-party database developer to deploy the remaining e-form reports.

The SCCPC has continued its partnership with the South Carolina Department of Administration's Division of Technology Operations (DTO). In January 2023, the SCCPC became the first South Carolina state agency to onboard onto Azure Government Cloud as a tenant under DTO. Azure Government Cloud is specifically built to meet state and federal government compliance and security requirements. The SCCPC is a tenant under DTO's government cloud and has worked alongside DTO as the SCCPC constructed the initial version of the internal facing data submission system, which will enable the sixteen judicial circuits' CMS to send report data automatically and securely to the SCCPC using Azure Government Cloud, which was successfully implemented in FY 24 for data relating to two reports. In FY 25, the SCCPC will continue to integrate with and collect additional data elements from CMS partners as a means of improved reporting scope and quality.

3. <u>Internal technology advances.</u> In addition to the SCCPC's cloud-based Prosecution Database project, the SCCPC will continue to focus on the development in other areas of the agency's information technology. With appropriated state funding from the FY 24 budget, the SCCPC was able to bring staff computing resources into spec by retiring out of warranty devices and replacing them with new machines. In FY 25, the SCCPC will continue to take strides to be technologically self-sufficient for its trainings. The SCCPC will also be implementing a new event management software platform to replace a decades old system currently being used. This system will not only simplify the event registration process for staff in the Offices of Circuit Solicitor but will also make communication with and the distribution of resources and materials to these offices more seamless. The system will also enable the SCCPC to track staffing more accurately within the Solicitors' offices.

The SCCPC continues offer virtual trainings (in addition to in-person trainings) for the Offices of Circuit Solicitor staff and will continue to refine this process in FY 25. Virtual meetings have enabled greater communication and coordination with the Offices of Circuit Solicitors and have promoted a more inclusive audience as many office staff who were previously unable to attend in-person meetings due to budgetary restrictions are now regularly attending virtual meetings held by the SCCPC.

4. Assist with statewide diversion program initiatives. The SCCPC continues to partner with the sixteen statewide Circuit Directors of Diversion Programs to identify and bring to the Circuit Solicitors' attention various issues affecting the performance of statewide diversion programs. In FY 24, the SCCPC continued coordinating Diversion Discourse calls, which are open to all diversion and treatment court personnel in the Offices of Circuit Solicitor and have the objective of sharing ideas, solutions, and enhancing the communication between diversion programs across the State. The SCCPC has seen increased participation and interest in these calls, which often include guest speakers on various diversion topics of interest and will continue to offer these calls as well as professional development and training opportunities.

For number of years, SLED has been working on upgrading its older BIS Diversion Database to a more robust and technologically advanced Diversion Database system. However, after SLED informed the SCCPC during FY 24 that they could no longer continue development on this upgrade or provide hosting support of the database, the SCCPC began working with DTO to plan a path

forward. After discussing our options with key stakeholders at DTO, it was recommended that we bring procure a vendor that would facilitate the unfinished development of the new Diversion Database and assist with the migration of the historical data from the BIS system. To accomplish these goals, DTO recommended that the new Diversion Database be relocated to a physical server at DTO and use this as the starting point for migration of SLED's historical diversion data as well as the go-live point for the new Diversion Database. As of the end of the first quarter of FY 25, the SCCPC and DTO are in the process of finalizing the Scope of Work for this project. The current BIS system only tracks participation in PTI Diversion Programs (PTI). Since PTI is only a small subset of total available Diversion Programs available statewide, our goal for the project is to further expand the capabilities of the New Diversion Database to allow for entry, tracking, and review of participation in and statistical data for all solicitor-run Diversion Programs in the Solicitors' offices statewide. An additional goal of the new Diversion Database is to allow for enhanced accuracy in diversion program reporting, reduce duplicate data entry, and provide a more user-friendly interface for the Offices of Circuit Solicitor.

#### IV. CIRCUIT SOLICITOR PLANS FOR THE CURRENT FISCAL YEAR AND BEYOND

The ongoing efforts and new initiatives of the sixteen elected circuit solicitors support the fair and swift prosecution of criminal cases, rehabilitation of offenders through diversion and treatment court programs, support for crime victims and witnesses, and public safety. The SCCPC's role is to coordinate and provide training programs, legal and legislative research and assistance, statewide prosecution data, legal and legislative updates and responses, and project assistance to support the solicitors' efforts. While the outcomes for the efforts and initiatives of the solicitors' offices are not directly under the control of or influenced by the SCCPC, the ability of the solicitors to carry out their efforts and initiatives is of utmost importance to the SCCPC and directly affects the ability of the SCCPC to effectively carry out the Commission's ongoing efforts and planned initiatives. Therefore, a brief description of these solicitor goals and plans follows:

1. Continued upgrades to technology in the Offices of Circuit Solicitor. With the non-recurring technology funding appropriated for the Circuit Solicitors in the FY 23 Budget (\$9,600,000 total distributed \$600,000 per circuit), the Circuit Solicitors have either selected a new case management system or are making upgrades and continuing maintenance of their existing case management system. Of the circuits that have selected new case management systems, some have already migrated to their new systems while others have scheduled dates for migration. In December 2023, each circuit reported their actual and planned technology expenditures of the appropriated non-recurring funding, which report was posted on the legislative website.

In addition to the one-time expenses associated with purchasing new case management systems, there are recurring annual licensing, maintenance, and support costs. The Offices of Circuit Solicitor also need of additional data storage for case files and videos, improved internet connectivity and bandwidth, and IT security enhancements. The solicitors' case management systems also need to interface or integrate with the SCCPC's database and local law enforcement agencies. While the appropriated non-recurring funding for technology has been instrumental in enabling the solicitors to purchase new case management systems or make upgrades to their existing systems, recurring funding will be required for several circuits for the increased maintenance costs associated with these systems as well as ancillary costs for enhanced internet service, evidence management systems, cloud data storage, and IT support services. Recurring state funding will be requested for FY 26 so that these necessary services can be acquired.

- 2. Assistant Solicitor Personnel and Retention. In the 2023-2024 Appropriations Act, \$14.53 Million in recurring funding was appropriated for the Offices of Circuit Solicitor to hire and retain assistant solicitors. This critical funding will enhance the ability of Circuit Solicitors to hire and retain prosecutors and reduce the backlog of cases. The Circuit Solicitors reported a goal of hiring 73-76 new attorneys statewide in FY 24. In furtherance of this goal, the Offices of the Circuit Solicitor participated in a variety of recruitment events, including job fairs, and utilized both traditional and newer methods (such as social media and other digital platforms) to advertise available prosecution positions. Based on this vital funding and these efforts, the Offices of the Circuit Solicitors were able to hire 77 new prosecutors. This funding was also beneficial for retention efforts, allowing the Offices of the Circuit Solicitors to retain experienced prosecutors by providing substantial raises to encourage talented prosecutors to continue their careers in public service and help stifle the attrition of prosecutors to the private sector that has plagued prosecution offices nationwide. At the end of FY 24, the Offices of the Circuit Solicitors had 34 more prosecutors than the start of the fiscal year. Vigorous recruitment and retention efforts will continue in FY 25. Once the solicitors' offices have an adequate number of prosecutors, efficient workflow processes can be implemented that allow for balance between case screening and triage, adequate case preparation time, and running court.
- 3. Non-attorney Prosecution Staff Personnel and Retention: While the funding appropriated and dedicated for assistant solicitors has been crucial for the operation of the solicitors' offices, additional funding is needed for other critical positions, including diversion program staff, victim/witness advocates, investigators, paralegals, IT staff and other administrative professionals. Funding is needed and will be requested for FY 26 to increase salaries in order to retain key staff, provide the additional prosecution staff needed to handle the increased warrant numbers, and to offset the drastic drop in court fines and fees revenue since FY 15 (which funding is used to support diversion and treatment court programs).

#### V. RESTRUCTURING RECOMMENDATIONS

The SCCPC does not have any restructuring recommendations for the elimination or combination of existing agency programs.

#### VI. RISK ASSESSMENT AND MITIGATION STRATEGIES


If the SCCPC does not meet its goals and objectives, the criminal justice system and the safety of South Carolina's local communities will be adversely impacted. The SCCPC coordinates communication and collaboration among the Offices of Circuit Solicitor and criminal justice partners; gathers and reports data and information for the benefit of the General Assembly, Circuit Solicitors, other criminal justice agencies and the public; develops and provides training for prosecutors, law enforcement, judges, diversion coordinators, victim advocates and others; and provides legal assistance to the Offices of Circuit Solicitor. Circuit solicitors face several challenges requiring enhanced prosecutor training and continuing legal education and additional support and assistance from the SCCPC. As the number and experience of prosecutors within the solicitors' offices change, the demands on the SCCPC continue to increase.

The mission of the South Carolina Commission on Prosecution Coordination (SCCPC) is to improve South Carolina's Criminal Justice System and enhance the professionalism, effectiveness, and efficiency of South Carolina's Circuit Solicitors and their staff by providing training, continuing education programs, administrative and programmatic support, and technical legal assistance for the Offices of Solicitor; by collecting, analyzing and distributing meaningful criminal justice data; and by collaborating with and assisting the General Assembly as well as federal, state and local criminal justice partners.

The SCCPC was created in 1990 to develop, coordinate, and provide training, resources, and support services for and to promote fair, just, and uniform administration of justice in the prosecution of criminal cases by the state's sixteen (16) Circuit Solicitors and their staff. The SCCPC is governed by Sections 1-7-910 through 1-7-1000 of the South Carolina Code of Laws. The Commission's eleven statutory members are the Chairmen of the Senate and House Judiciary Committees or their legislative designees, the Chief of the South Carolina Law Enforcement Division, the Director of the Department of Public Safety, a director of a Judicial Circuit Pretrial Intervention Program (PTI), a Judicial Circuit Victim-Witness Assistance Advocate, and five (5) Judicial Circuit Solicitors appointed by the Governor.

In furtherance of its mission, the SCCPC's primary responsibilities include:

- · Development and coordination of efforts to improve the prosecution and disposition of criminal cases in a timely and efficient manner;
- Administrative and programmatic functional support for the Offices of the Solicitor;
- · Collection of revenues and expenditures of the Offices of Solicitor as well as programmatic data for reporting as required by the South Carolina General Assembly;
- Coordination of pretrial intervention and other diversionary programs within the Solicitors' offices;
- Development of training and legal education programs for solicitors and their staff to help improve the legal knowledge and advocacy skills of prosecutors, the investigation of crimes, the administration of diversion programs, and the provision of victim services;
- · Publication of newsletters, manuals and other materials to help Circuit Solicitors and staff achieve peak job performance;
- Provision of information and assistance on legal and ethics issues;
- · Coordination of efforts with other federal, state and local government agencies involved in the criminal justice system; and
- Communication with non-governmental entities involved in the criminal justice system, including the South Carolina Bar, and entities representing the interests of crime victims and criminal defendants.
