## AGENCY'S DISCUSSION AND ANALYSIS

Coastal Carolina University (CCU) is a comprehensive, public liberal arts institution located in Conway, South Carolina, just minutes from the resort area of Myrtle Beach. CCU is accredited by the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) and currently offers baccalaureate degrees in over 115 undergraduate and over 30 graduate-level (doctoral, educational specialist, masters) major fields of study including specialized concentrations across seven colleges. The CCU Fall 2023 combined undergraduate and graduate student enrollment was 10,829 while Fall 2024 preliminary enrollment currently stands at 11,193 students. This is a record enrollment for CCU.

The University comprises 115 main buildings on the walkable campus and the General James Hackler Golf Course at CCU. A 1,105-acre tract that includes a portion of Waties Island provides a natural laboratory for extensive study in marine science and wetlands biology on an Atlantic coast barrier island.

CCU's has established a new strategic plan named CCU Reach – Our Tealprint for the future. This new plan is inspired by the words in the CCU alma mater, "We come to you to lead our search, and learn to reach beyond ourselves...". CCU Reach focuses on three pillars: learning, living, and legacy, as well as keystones. The pillars anchor CCU in purpose and move the University toward a shared vision, while the keystones provide the infrastructure needed for the pillars to stand firmly. As part of CCU Reach, CCU strives to prepare students for success, have a thriving campus environment, make a difference beyond our campus, and create a stable future for Teal Nation by driving efficiency and sustainability.

CCU's new Campus Master Plan was adopted by the Board of Trustees during 2023-2024. The Campus Master Plan addressed the increasing needs of the university along with sustainable facilities recommendations and enhancement of CCU land. The plan researched academic, space and infrastructure data to inform a phased build-out of the campus to meet existing and projected needs. With this plan in place, "CCU is poised to become, even more than it is now, a university of choice for learning, researching, experiencing college life, expanding horizons, and contributing positively to our communities.

Total revenues reported in fiscal year 2024 were \$297,452,820, a \$32.6 million increase over fiscal year 2023. Student tuition and fees made up 55 percent of that revenue, or \$164,589,420. Sales and services were 16 percent or \$46,397,832; state appropriations were 11 percent or \$32,495,119; scholarships, contracts, and grants were 8 percent or \$25,149,507; and gifts and grants and other operating and non-operating revenues accounted for the remaining 10 percent of revenues recognized this fiscal year.

### **Financial Highlights**

- The viability ratio is a financial metric used to assess an institution's financial health and sustainability by measuring its ability to cover long-term debt with available expendable net assets. Generally, a ratio greater than 1.00 indicates that the institution has sufficient expendable net assets to cover its long-term debt, signifying a strong financial position. The University ended fiscal year 2024 with a viability ratio of 1.34, reflecting a 19 percent increase from the fiscal year 2023 ratio of 1.13.
- The adjusted net operating revenues ratio assesses an institution's ability to generate a surplus. The formula for the ratio is adjusted net operating revenues (operating revenues plus state appropriations and federal Pell grants, less operating expenses) divided by adjusted operating revenues (operating revenues plus state appropriations and federal Pell grants). A positive ratio indicates that the institution has funding available to reinvest towards its strategic initiatives. For fiscal year 2024, the University operated at a 5 percent margin, outperforming the previous year's ratio of 1 percent.

• The prime reserve ratio is a measure of how poised an institution is to handle uncertainty and is derived by dividing expendable net position by total expenses. Typically, a good benchmark for a prime reserve ratio is 40 percent. The University ended fiscal year 2024 with a prime reserve ratio of 80 percent, which indicates the University is in a strong financial position.

The University continues to lobby for additional funding in the form of state appropriations. In fiscal year 2024, the state approved non-capital appropriations of \$32,495,119, a 27 percent increase from the prior year. In addition to operational funding, the state set aside \$7,500,000 in support of capital renovation and maintenance projects. Coastal Carolina University also receives a monthly allocation from the Horry County one-cent sales tax, providing \$16,868,771 during fiscal year 2024 restricted for capital improvements. Local appropriations give the University the ability to invest in projects that positively impact Horry County and its citizens.

The University is also committed to financial viability and managed growth. Total Fall 2023 enrollment was 10,829, a 14 percent increase over the past ten years (Fall 2013 enrollment of 9,478). The preliminary Fall 2024 enrollment is trending to be record setting for CCU. Total full-time equivalency (FTE) enrollment for Fall 2023 of 10,459 represented an 18 percent growth over the past ten years (Fall 2013 total FTE of 8,863).

Academic year 2024-2025 in-state tuition rates remain the same as the prior five academic years. For an instate undergraduate student, tuition is set at \$5,820 per semester which is 5 percent, or \$628, below the average rate of South Carolina four-year public institutions. Academic year 2024-2025 out-of-state undergraduate tuition rates remain the same as the prior academic year at \$14,814 per semester.

**Risk Assessment and Mitigation Strategies** – A failure of the University to accomplish its mission and goals could result in the institution not maintaining and improving the quality of the student experience. The University's stakeholders continue to expect quantifiable results and transparent reporting of student retention, graduation rates, and career readiness. As accountability from the stakeholders increase and funding declines, operational efficiencies and cost management become key to a University accomplishing its mission and goals of providing a quality student experience. The strategic planning, budgeting, and assessment process allows the University to flexibly respond to present and future initiatives with the innovative approaches that are required due to limited resources. Planning for the University's future and the accomplishments of strategic objectives are paired with annual fundraising events and long-term campaigns. The strategic planning process focuses on the development of strategic priorities which guide resource allocation.

Three options for what the General Assembly could do to help resolve the issue of not maintaining the quality of the student experience are to:

- 1. Disburse equitable funding on a per in-state student basis to allow each student to benefit from the same amount of state financial support regardless of which institution they attend.
- 2. Minimize reporting requirements which will allow the institution to focus on maintaining and improving the quality of the student experience.
- 3. Legislate expanding the four percent cap on scholarships. In an effort to keep tuition affordable for our in-state students, consider revising or abolishing this scholarship cap for in-state students. The University's goal is to make tuition as affordable as is feasibly possible, and this limit inhibits abilities to reach this goal.

## Goal 1 – Education, Training, and Human

Strategy 1.1 – Academic Excellence and Instructional Quality - Foster academic excellence through a teacher-scholar model with enhanced and supported effective teaching and scholarly/creative endeavors, expanded learning opportunities, and engagement of all campus community members.

## **Objective 1.1.1** – Increase the six-year graduation rate by 2%.

**Result** – The first-time, full-time student cohort from Fall 2016 had a 48.0% six-year graduation rate. The first-time, full-time student cohort from Fall 2017 had a 50.8% six-year graduation rate. This represents a one-year increase of 2.8%.

### Activities –

- University Advising conducts a "program evaluation review" for all freshmen and sophomore students at the end of each major semester to ensure that students are registered for courses that align with their degree program.
- Student participation in FACETime with Faculty, a program designed to encourage students to attend faculty office hours, saw over a 100% increase from 2022-2023 to 2023-2024 with 910 and 1,985 unique student participants, respectively.
- The Student Opportunity for Academic Recovery (SOAR) program, a program for first-time freshmen on academic probation, continues to increase the percentage of students who are in good academic standing upon completing ACED 101, which is a key component of the SOAR program.
- Predictive modeling has been developed to help identify and provide support to first-time freshmen who may be at-risk of being on academic probation at the end of their first semester. This is a collaborative effort between the Office of Institutional Research, Assessment and Analysis, Coastal Student Success Center, and University Advising and will continue into the coming years.

**Objective 1.1.2** – Increase undergraduate and graduate student FTE population by 2 percent. **Result** – Fall 2019 undergraduate FTE was 9,531 while Fall 2023 undergraduate FTE was 10,147. This represents a 6.5 percent increase in undergraduate FTE from Fall 2019 – Fall 2023. The total Fall 2023 graduate student FTE was 314, which represented 3.0 percent of the total FTE enrollment for Fall 2023. The total FTE was 303, which represented 3.1 percent of the total FTE enrollment for Fall 2022.

**Activities** – CCU engaged in a series of high-quality innovative programs to increase undergraduate and graduate student success including:

- Continuing use of the Coastal Student Success Center to include the Academic Coaching Experience and SOAR Program, the Mathematics Learning Center, Writing Center, and the following programs: CINO Accelerate, Coastal Excellence and Leadership (CEaL) Program, and Bridge Program. Staff to support these efforts were hired, courses were created and taught, as well as workshops and presentations conducted.
- Beacon, an early alert system, allows individuals that frequently interact with a student the ability to identify trends inside and outside of the classroom. Active use across campus departments ensure students are connected with resources in a timely manner.
- Degree program additions during the 2023-2024 academic year included two bachelor of science programs, two bachelor of art programs, one bachelor of professional studies, and one master of accountancy (online) program.

- The College of Graduate and Continuing Studies implemented a reduced tuition rate for South Carolina Technical College System employees pursuing graduate degrees.
- A new CRM system to automate graduate recruitment and application processes was
  implemented in the College of Graduate and Continuing Studies. With the new CRM system, data
  collection happens at every element of the admissions funnel (prospect to enrollment), more
  timely responses to inquiries are able to be provided, and have more of an ability to target specific
  populations for recruitment.

Strategy 2.1 – Student Excellence - Promote an educational environment that engages students to develop knowledge, learn and apply skills, and act as responsible, healthy and productive citizens with a global perspective.

**Objective 2.1.1** – Increase student participation in student engagement opportunities by 2%. **Result** – During the 2023-2024 academic year, 195 student engagement opportunities were offered with 10,089 students attending. This represents an increase of 41% in student participation in student engagement opportunities from 2022-2023. **Activities** –

• Within the Division of Belonging and Student Affairs, the Office of Student Engagement supports student organizations and leadership, fraternity and sorority life, orientation, transition, and family programs, military and veteran services, intercultural and inclusion student services, and career services. These offices were able to hold a variety of engagement events for students during 2023-24. Below is a list of events by category and number of attendees:

**Objective 2.1.2** – Increase international student enrollment to 3% of total student enrollment. **Result** - In Fall 2023, CCU had a total of 161 international students (1.5 percent of total student enrollment) from 53 countries enrolled.

Activities –

- For 2022-23, total international applications increased by 12.31 percent over 2021-22, and acceptance decisions were up 18.4 percent over 2021-22. International Freshman applications were up 3.78 percent with acceptance decisions up 35.59 percent. International Transfer applications were up 30.61 percent with acceptance decisions up 50 percent. International graduate applications were up 82.98 percent with acceptances flat between 2022-23 and 2021-22. Moved to student enrollees increased 12.99 percent in 2022-23 over 2021-22 to a total of 87.
- This number of applications exceeded the largest number of applications received and the largest number accepted and moved to student in a given year, with 365 applications and 87 moved to student respectively in 2022-23. Highest numbers for applications and moved to student figures before were in 2021-22 (312 applications and 73 moved to student) and in 2016 (278 applications and 85 moved to student) respectively. The percentage of enrolled (moved to student) students to those who were accepted from 59 percent in 2022-23 as compared to 62 percent in 2021-22, but given significant staffing turnover mid-year of 2021-22 in our international recruitment and admissions team, this was not unanticipated as an outcome.
- After our significant staffing turnover from mid-year 2021-22 through 2022-23, we reorganized tasks/duties, completed a lean management swim lane evaluation of all processes tied to international recruitment and admissions, prioritized task and process revisions given that process, and then streamlined processes and advanced processes and tools that will assist as we brought new colleagues into those positions.

# Strategy 3.1 – An Engaged Staff and Faculty - Foster a community of engaged and qualified staff and faculty by providing them with resources, opportunities for professional development, recognition of their contributions and successes, and personal enrichment.

**Objective 3.1.1** – Increase professional development and training opportunities for faculty and staff by 3%.

**Result** – The Office of Professional Development, with four staff members, is responsible for faculty and staff development across campus. The Office of Professional Development has implemented programs based on needs assessments of faculty and staff. There were approximately 347 professional development opportunities offered to faculty and staff during 2023-2024. This is a 56% increase of opportunities available for faculty and staff from 2022-2023.

### Activities –

- Professional development activities included sessions such as: New Faculty Orientations for fulltime and part-time faculty; New Faculty Q&A Sessions; New Faculty Academy; New Chanticleer Day for new staff; Teaching Effectiveness micro-certificate; Artificial Intelligence sessions for faculty and staff; Breakfast Series: Getting to Know Teal Nation; CliftonStrengths Individual Coaching; CliftonStrengths Team Coaching; External speaker Jay Dolmage (expert on academic ableism); Communities of Practice (for directors, assistant/associate directors, and administrative assistants for peer-to-peer learning and problem solving); Reading with Colleagues; Writing with Colleagues; Wellness Week for faculty and staff; Wellness Series & Sessions; Campus Systems & Services; Quality Matters: Applying the Quality Matter Rubric; Instructional Coaching; and Core Course Planning, Recertification, and Assessment.
- The Office of Professional Development moved to one registration website for professional development activities.

• The Office of Professional Development held an End-of-year Celebration to present certificates and recognize campus partners who teach professional development sessions.

## Strategy 4.1 – Accessibility, Inclusion, Diversity – Engage students, faculty, staff and the greater community in a partnership of learning grounded in the liberal arts, based on respect for diversity and inclusion.

**Objective 4.1.1** – Increase underrepresented minority student enrollment by 2%. **Results** – The Fall 2022 underrepresented minority (URM) student enrollment was 2,660 while Fall 2023 URM student enrollment was 2,292. This represents a four percent decrease in underrepresented minority student enrollment for one year. This is attributed to a decrease in the number of students who reported an ethnicity or race to the University during the Fall 2023 admission process. **Activities** –

- The College of Graduate and Continuing Studies secured two doctoral fellowships for Coastal Carolina University through Southern Region Education Board (SREB). The SREB Doctoral Scholars program is specifically designed to increase the number of historically underrepresented students who earn doctorates and choose to become faculty at colleges and universities.
- An annual process has been developed for enrolled students to update demographic information such as name, address, phone number, gender, ethnicity/race, and veteran status. This process provides students process information for updating each piece of information if needed. They are not required to make any updates.

## Strategy 5.1 – The CCU Story – Effectively communicate the goals, successes, contributions and needs of our University, students, faculty, staff, and alumni

**Objective 5.1.1** – Implement a repository for communicating accomplishments by students, faculty, and staff.

**Results** – The University completed the RFP process to purchase a new faculty management and reporting software, Watermark, in September 2023. Watermark allows for the collection of accomplishments from faculty and student, as well as the submission of annual reviews and promotion and tenure files. Implementation with Watermark has been completed.

## Activities –

• The implementation of Watermark happened in two phases with the following modules: Faculty Accomplishments (FA) and Report, Promotion, and Tenure (RPT). An implementation Committee was established that included representatives from the Provost Office, the system administrators, and one associate dean and faculty member from each college. This committee helped answer questions about processes within each college to ensure the modules reflected what faculty members would need to submit. The FA module was built and will be available for faculty to input data in the 2024-2025 academic year.

# Strategy 6.1 – Financial Stability and Infrastructure - Support University excellence by ensuring appropriate resources and infrastructure for its long-term viability with a strong focus on fiscal accountability, transparency, planning, fundraising and innovative outreach activities.

**Objective 6.1.1** – Increase the number of grant applications 2%.

**Result** – In FY2023-2024, there was a total of 151 new funding proposals created and at least partially completed by the Office of Sponsored Programs and Research Services (OSPRS), with 106 ultimately submitted to a federal, state, municipal, foundation or private funder. While this represents less than a 1% decrease from the previous fiscal year total of 108, it also represents an increase of 1% increase in the total amount of funding requested over FY2023-2024 of 1% at \$13,553,014.

To date, 43 of the FY2023-2024 proposals have been funded for a total of \$4,965,581, representing a nearly 76% increase in new funding over this time last year, with an additional four proposals totaling \$1,099,848 in *recommended for award* status with federal agencies. With these four agencies' budget requests expected to be approved, we will secure \$6,065,429 in new funding for FY2023-2024. In addition, there remain nine proposals totaling \$1,482,997 which are still in *review* status by the funders. **Activities** –

- Increase support services for faculty and staff.
  - Through the Director, continue to work with University administration, College Deans and other support offices to improve policies, processes and systems that impact the ability for faculty and staff to apply for, accept or manage grant awards.
  - Through the Grants Management Specialist, continue to enhance the OSPRS website to provide more opportunities for on-demand, self-service options for access to information and supports to find funding, prepare proposals and manage grant awards.
  - Through the addition of our new Senior Post-Award Research Administrator, continue to build more efficient processes and procedures across the campus service offices in support of award management on the programmatic and fiscal side to improve faculty and staff experience of grant award management.
  - Recruit, train and fully onboard a new Senior Pre-Award Research Administrator who will be the first line support working with faculty, staff and graduate students seeking external funding to build complete, compliant and responsive proposals that lead to increased awards.
  - Continue to build on relationships with local, state, federal, and foundation sponsors to learn of opportunities early and often.


**Objective 6.1.2** – Implement a comprehensive campaign with a goal of raising \$75,000,000 by 2029. **Result** – The balance of the endowment totaled \$76,236,251 for the FY 2023-2024 as of 08/29/2024. By 8/29/24 CCU has raised 47% of its goal of raising \$75 million by 2029. This was accomplished through many large philanthropic gifts to the university both to academics and athletics. Additionally, added members to the Advancement and Alumni Engagement team assisted with fundraising efforts and alumni outreach.

Activities –

- 19<sup>th</sup> Annual Homecoming Golf Tournament (October 27, 2023) This annual golf tournament engages alumni, donors and community with proceeds totaling \$19,477.54 supporting six endowed scholarships.
- Giving Teal Tuesday (April 16, 2024) This was a 24-hour day of giving that is held annually. During that single day time, CCU raised \$308,078.06 in cash and pledges, its largest one-day fundraising effort to date.
- Boots and Bronze (July 14, 2023) This annual fundraising reverse raffle, silent auction and dinner proceeds totaled \$3,637.73 through tickets sales, donations, and silent auction with the net proceeds after expenses supporting six endowed scholarships within the Alumni Association.
- Brick Campaign During the FY23, bricks sold for installation on the alumni walkway generated \$3,727.32 in revenue.
- Offered eight alumni TEALgates ranging from 500 to 1,000 attendees at each.
- Hosted alumni events in four cities and one country Washington, DC, Myrtle Beach, SC, Greenville, SC, Tampa, FL, and Iceland.

- The Wall College of Business received a \$900,000 planned gift towards the Furtner Family Endowed Scholarship which provides scholarships for recipients enrolled within the College of Business.
