AGENCY'S DISCUSSION AND ANALYSIS

020F

USC Salkehatchie is a dynamic regional campus serving the rural Lowcountry. The University is one of the anchors in the community and a key for future growth and prosperity in a region characterized by widespread poverty and a declining population. Despite challenges inherent to its region's economic conditions, USC Salkehatchie successfully strives to meet ambitious goals. Incorporating the new USC Columbia and Palmetto College's strategic plans, this report sets forth USC Salkehatchie's goals for the upcoming year. USC Salkehatchie has and will continue to **grow enrollment, advance student success, deliver world-class experience for students, internal colleagues, and external partners, and impact educational attainment.**

Changes to leadership and reorganization across the campus resulted in an increase in enrollment, retention, and community engagement. With new leadership in place across various departments, including positions such as director of educational partnerships, athletic director, associate dean for academic and student affairs, and soon, assistant dean of enrollment services and student success, the future of USC Salkehatchie appears promising, and metrics are improving.

Growing enrollment and advancing student success

In FY 2023, USC Salkehatchie's headcount increased and current numbers reflect continued movement in a positive direction. Visibility in the community, broader community engagement, and our social media presence contributed to an increase in applications and interest in our campus. Enrollment growth is both a short-term and long-term focus for USC Salkehatchie, and the move toward a larger student body is balanced with a desire to recruit and retain students committed to learning. USC Salkehatchie serves as an alternate access point to higher education for students whose situations whether economic, personal, or academic—will not allow them to begin immediately at a four-year campus. USC Salkehatchie's tuition and required fees are tied with the other Palmetto College campuses as the lowest financial threshold to a university education in the state, and tuition and required fees were not raised in the last few years. At USC Salkehatchie's 2024 Commencement, 116 Associate in Art and Associate in Science degrees were awarded to students. Furthermore, the expansion of academic offerings through Palmetto College is enabling USC Salkehatchie to serve more students locally and for longer. While some students pursue baccalaureate degrees at other institutions after completing the first two years of higher education at USC Salkehatchie, many others are now taking advantage of collaborative programs in nursing, education, and Palmetto College online classes, to complete the requirements for baccalaureate degrees without having to leave the Salkehatchie area. USC Salkehatchie's 2024 Commencement included the awarding of 19 baccalaureate degrees through its partnerships. USC Beaufort at USC Salkehatchie nursing graduates earned a 100% first-time NCLEX-RN pass rate. All of the above numbers represent students taking advantage of life-changing opportunities.

The expansion of academic offerings is essential for the achievement of USC Salkehatchie's mission as an institution of higher education. Indeed, USC Salkehatchie consistently strives to find new and innovative ways to fulfill students' long-term educational goals and meet the educational needs of its communities. Many potential students in our service area are unable to attend classes in-person. USC Salkehatchie offers online associate degrees, giving the community another way to access higher education. USC Salkehatchie embraces USC's Graduation with Leadership Distinction (GLD), grant funded STEM internships, and opportunities for Magellan Scholars research and PURE summer research grants expanding experiential-learning opportunities. USC Salkehatchie's long running efforts to form community and local industry partnerships that facilitate and inspire student internship opportunities and career paths included the recent creation of a digital bulletin board for internships and job opportunities.

Our upcoming plans include the completion of the Student Commons and Conference Center in Walterboro, which will house classrooms, a weight room, a student lounge and other meeting spaces that will also be available to the public.

World-Class Experiences for Students, Internal Colleagues, and External Partnerships

USC Salkehatchie continues to emphasize faculty excellence by striving to offer competitive salaries, providing opportunities for greater intellectual challenge through the teaching of upper-level courses in Palmetto College, providing support for engagement in scholarship and research, and by encouraging involvement in campus and local-community service. The greater University has shown support by making internal grant opportunities available to Palmetto College campuses faculty (as well as students for undergraduate research), and USC Salkehatchie faculty has responded by regularly winning these grant awards, including ASPIRE, RISE, and PROPEL, thereby enhancing their scholarly production/expertise in their fields. Faculty mentor students most notably through GLD research projects, Magellan grants, and summer PURE grants. Overall, USC Salkehatchie faculty has been highly successful with scholarly production and grants. USC Salkehatchie faculty traveled internationally 5 times to present research and to 35 regional or national conferences. Faculty produced 3 creative works including the curation of the SALK Herbarium Project.

The Early College program expanded to two cohorts on the Walterboro campus and one cohort on the Allendale campus. The Salkehatchie Scholars program expanded to 18 students and encourages motivated students to start their academic careers at USC Salkehatchie. This upcoming year, we are developing a defined pathway from high school Teacher Cadet programs to our Education degree program (in partnership with USC Aiken). Grant funding awarded by the Department of Energy-Environmental Management and National Nuclear Security Administration, administered through Savannah River Site Community Reuse Organization (SRSCRO) has provided new scholarships for STEM majors. Our athletic programs excelled in academics with 5 student-athletes on the President's List and 22 on the Dean's List. This is nearly 25% of all athletes. Our men's basketball team won the NJCAA Region X championship and played in the national tournament in Hutchinson, KS.

Within greater USC's "Experience by Design" quality enhancement program (administered by the Center for Integrative and Experiential Learning), USC Salkehatchie continues to support faculty members who involve students in internships, independent research, and other modalities of experiential learning. USC Salkehatchie seeks to increase the number of students involved in service learning and Graduation with Leadership Distinction (GLD) honors. USC Salkehatchie continues to provide campus activities and programs that are designed to enrich the experience of its students and enhance its communities.

Impact on Educational Attainment

Educational attainment is the cornerstone of USC Salkehatchie's mission, but community outreach efforts demonstrate the institution's creativity in meeting local needs. Full-time faculty reported over 900

hours of community service in 2023. The director of student activities partners with community organizations, such as New Life and Pillars of Hope, for events on campus. Each semester a Career and Organization Fair invites the community to offer booths encouraging student engagement.

The USC Salkehatchie campus is available to our community partners for events and can be rented by private groups. One recent event was the Southern Palmetto Regional Chamber of Commerce annual State of the Region event.

The Salkehatchie Leadership Institute, the community-outreach arm of the university, assists municipalities and community groups with economic development and other projects that strike directly at the quality of life experienced by the residents of the region. Among its many efforts, the Institute sponsors a "Take Flight!" Aviation Camp for 8th graders from Allendale and Colleton Counties, partnering with The Boeing Company, the local chapter of the Tuskegee Airmen, Joint Base Charleston, and local school districts. The Institute also provides a six-month advanced leadership program, Leadership Salkehatchie, for civic leaders residing in the six counties of Allendale, Bamberg, Barnwell, Colleton, Hampton, and Jasper, sponsored by a local economic development partner, SouthernCarolina Alliance. The Institute was instrumental in renovations made to the historic Carolina Theatre, accomplished in part through a USDA Rural Development grant, completed in 2013. Since that time, the theater has proven to be an important space for use by theater classes and has hosted numerous cultural and university events.

Additionally, USC Salkehatchie was selected as a partner in an initiative by Savannah River Nuclear Solutions and the Department of Energy for Workforce Opportunities in Regional Careers grants

(WORC I and WORC II). Through this partnership, we have been able to focus our efforts on strengthening regional workforce pipeline development and promoting STEM career opportunities available through USC Salkehatchie, including our Associate of Science, the 2+2 Industrial Process Engineering program with USC Aiken, and the Computer Science program (with an emphasis on Cybersecurity) through Palmetto College, while providing support to students through free peer tutoring, scholarships, individualized internships, experiential learning, and mentoring. This partnership and its impacts extend beyond current USC Salkehatchie students, to K-12 students and community members throughout the service area. Hands-on STEM outreach events, led by our STEM Coordinator with support from current Salkehatchie STEM student ambassadors, expose and motivate participants, while simultaneously increasing awareness of the possibilities available regionally.

In 2022, the iCarolina Learning Labs opened on both campuses. The labs have offered community classes, university classes for students, faculty, staff, and the community, and iCarolina Kids Camps each summer.

In preparation for an informed workforce, USC Salkehatchie offers internships both on- and off-campus. The campus continues to offer college courses for qualified high school students and an Early College program for interested and engaged students. Our high school partners continue to be the pipeline for the education program through Teacher Cadet courses.

Overall Analysis




strategic planning processes (and the upcoming revisions), the institution has important guiding

The Salkehatchie regional Palmetto College campus is a branch campus of the University of South Carolina Columbia. Salkehatchie has as its mission to provide higher education and intellectual leadership, contributing to the primary mission of the University of South Carolina System so stated as "outstanding education, research, creative activity, community engagement, and service that drives community and economic impact or the benefit of the state, nation, and world." At the heart of this mission is a teaching faculty of high quality dedicated to excellence in instruction, scholarship, public and professional service and creative endeavor which enrich the classroom experience. The Salkehatchie regional Palmetto College campus offers a varied curriculum grounded in the liberal arts and focused on preparing students to continue their education in the University of South Carolina System and throughout life.

The Salkehatchie regional Palmetto College campus recruits students prepared to succeed in completing a baccalaureate-level education. While the institution does not offer remedial instruction, it is nonetheless able to admit most students who apply due to the close working relationship between students and faculty. The original design of the institution incorporated a flexibility that has allowed changes in institutional capability with increasing educational demands of constituents.

Through classroom and laboratory instruction delivered in a variety of face-to-face and distance learning formats and modalities, the institution awards the Associate in Arts and Associate in Science degrees and provides for the completion of selected bachelor's degrees on campus through cooperative agreements and delivery structures with other University of South Carolina System institutions. The Salkehatchie regional Palmetto College campus also provides general education and upper division coursework applicable to baccalaureate degree programs offered through colleges and universities nationwide. In addition to academic coursework, the mission of the campus includes noncredit courses, seminars, and workshops made available to the community for cultural enrichment and professional development.

The traditions of cultural diversity and freedom of thought are valued at the Salkehatchie regional Palmetto College campus. In a learning environment that develops respect for racial, geographical, intellectual, and economic diversity and an awareness of individual, societal, and global responsibilities, Salkehatchie promotes courses, activities, and attitudes that instill in students a thirst to continue learning throughout life.

The Salkehatchie regional Palmetto College campus emphasizes the development of the whole person and especially seeks to foster in students the disciplines essential to an educated citizenry. Core competencies, including the ability to communicate through effective writing and articulate speech; computational and quantitative mastery; creative and critical thinking; and the duties of citizenship are strategically integrated within the curriculum. Classroom experiences, student activities, and physical education programs also provide opportunities for cultural enrichment, leadership development, intellectual growth and interpersonal relationships, all contributing to a sense of self-reliance and a joy of learning.
