AGENCY'S DISCUSSION AND ANALYSIS

In order to attract and retain officers, the department began crediting newly-hired law enforcement officers' prior law enforcement service time. The initiative began in 2021, with recognizing officers with prior law enforcement service time in South Carolina. In November 2023, it expanded to officers with South Carolina Law Enforcement Officer I certification equivalents, as determined by the South Carolina Criminal Justice Academy. Officers with prior service time currently join the South Carolina Highway Patrol (SCHP), State Transport Police (STP), or Bureau of Protective Services (BPS) at the non-supervisory rank and salary correlating with their cumulative service time.

To improve retention efforts and build confidence for female troopers/officers, SCDPS partnered with Fortis Tactical Systems to offer a Female Officer Survival School. The course was developed specifically for female officers and is instructed by certified female defensive tactics, ground defense, firearms, and advanced training instructors. More specifically, the course included tactical fitness, basic range skills, defensive tactics, and classroom discussion regarding mental health, resiliency, and emotional survival. It also incorporated scenario-based training and practical application to build competency and increase confidence.

The department initiated the opportunity for Adaptive Scheduling to efficiently assign staffing resources. SCHP identified various posts which would benefit from a reduction in scheduled personnel between the hours of 2am – 6am. This reduction would allow supervisors to reallocate resources to coincide with peak call volume hours while still providing a trooper to respond between 2am – 6am in an "on-call" status.

Additionally, the department continues to focus on providing employees with leadership training to enhance employee retention. These leadership training opportunities include:

- First Line Supervisory Training for Corporals Similar to the Field Training Officer program, this program provides new first line supervisors initial classroom training to be followed by field training with a current supervisor who holds the rank of Corporal or higher.
- FBI LEEDA Training The department provided funding for employees to attend the FBI LEEDA Trilogy Leadership Series. Each participating supervisor attended the course correlating to his/her position. The courses are Supervisor Leadership Institute, Command Leadership Institute, and Executive Leadership Institute.
- Supervisory Practices Training The Office of Human Resources (OHR) procured training through the South Carolina Department of Administration which is titled "Supervisory Practices." This proctored training continues to be delivered to supervisors (law enforcement and civilian) with content covering thirteen (13) critical areas of supervisory development.
- Adaptive Leadership Training This program was developed internally to emphasize the importance of basic interpersonal skills when interacting with subordinates; assist SCDPS law enforcement supervisors in understanding their own personalities; demonstrate the vast array of personalities within law enforcement; and illustrate the need to tailor supervisory techniques to effectively supervise each employee.
- Incident Command System Training (Tiered Program) To create a strong emergency response strategy, Incident Command System training is critical for personnel within all functions of

emergency management and teaches incident response concepts and principles of the National Incident Management System (NIMS).

The department has created a Facebook page for family members of new recruits who are currently completing Basic Training. This Facebook page is utilized to disseminate valuable information to family members and provide pictures of recruits as they reside at the South Carolina Criminal Justice Academy for training. Additionally, SCDPS hosts family engagement sessions for new recruits' families to prepare them for their officers' schedules and job duties and build strong support systems for troopers/officers as they begin their careers in law enforcement. The department believes this will result in lower attrition and, most importantly, increased trooper/officer morale.

Family Resource Hub - SCDPS has established a quick-reference QR code which leads to all resources available to SCDPS employees and their families to help support its personnel. These include:

- ComPsych Guidance Resources The department procured the services of ComPsych Guidance Resources to provide ongoing, comprehensive, and convenient access to mental health counseling, health and wellness offerings, and life resources (e.g., financial counseling and dependent care referrals). These services are available to SCDPS employees and their families.
- Blue365 Offered to all state employees through BlueCross and BlueShield (BCBS), this program provides discounts associated with health and wellness to include vacation destinations, transportation, gym memberships, healthy lifestyle meal plans, and many others.
- Discount programs from the Department of Administration to include PerksCard, TicketsatWork, and WeSave.
- South Carolina Law Enforcement Assistance Program (SCLEAP) A service offered to law enforcement and their families for behavioral health benefits, post-critical incidents, traumatic loss, substance abuse services, suicide intervention, stress management, and peer support.
- Meru Health A mental health program built on continuous access to therapists through BCBS. Meru Health is a focused 12-week program, available via scheduled video calls and unlimited inapp chat, which has been clinically proven to deliver superior and long-lasting results.
- #MovewithDPS Monthly movement challenges with modification for all levels. This program introduces one (1) exercise a month and includes a guided video and instruction on proper technique and form.

The department equates visibility to deterrence. To create greater visibility on major interstates with area coordinated enforcement, SCHP's Area Coordinated Enforcement Team was restructured into three (3) interstate teams—an upstate team, a mid-state team, and a low-state team. The primary focus of these teams is to conduct enforcement on the interstate highways and areas around the interstates to deter traffic collisions and fatalities. These teams conduct high-visibility enforcement on violations which are proven contributors to collisions.

To create greater efficiency, the department reassigned the management of the Central Evidence Facility (CEF) to the Office of Support Services in August 2023. CEF personnel coordinate scheduled evidence pickup times with all law enforcement divisions, eliminating the need for delivery of evidence to CEF. Work hours associated with the previous delivery responsibility has been returned to the Troops, Regions, and Divisions, resulting in increased staffing levels in the field to conduct proactive enforcement. CEF has also procured an incinerator to destroy certain types of evidence in-house as

opposed to transferring the evidence to the South Carolina Law Enforcement Division (SLED) for destruction.

CEF conducted an audit during FY 2023-2024 which verified stored evidence against court documents, identifying over 5,000 pieces of evidence for destruction which were related to adjudicated cases and had met their retention requirements.

The department has completed major capital improvement projects at its headquarters and field office locations to include an HVAC replacement, a 500-ton chiller replacement, a service elevator refurbishment, restroom piping replacement, an emergency generator replacement, multiple commercial motor vehicle scale replacements, and law enforcement office relocations.

It is a priority to protect confidential information entrusted to the department. The department migrated to current, cyber-compliant Division of Technology (DTO) operated firewalls, replacing and retiring aged SCDPS devices. SCDPS information security monitoring employees stand ready to respond around the clock and reply within one (1) hour of receiving notification of a possible information security incident.

SCDPS strives to continually improve its information technology infrastructure and streamline operations. The agency's network was reconfigured so all sites, including vehicles, can connect directly to DTO's data center, rather than routing through SCDPS Headquarters. The new network configuration results in a more efficient data flow. The department's National Crime Information Center (NCIC) connection to SLED no longer requires a dedicated circuit and router. The department deployed new routers at every SCDPS location; the new routers increase bandwidth at all locations without additional cost. The increased bandwidth results in significant time savings for data uploads/downloads (e.g., Taser docks) from agency offices, increasing the amount of time troopers/officers can focus on enforcement efforts. The Office of Information Technology (OIT) has also collaborated with other divisions to streamline administrative and data entry-related tasks, saving a significant number of man hours and allowing troopers/officers to focus on proactive enforcement and respond to calls for service. A few examples are below:

- OIT established a means to view activity in Mobile Forms, saving an estimated 756 man hours each year.
- Based of feedback from troopers/officers, the department has worked with SmartCOP to make ninety-three (93) edits to reports and forms troopers/officers use daily, making the data entry process quicker and more efficient.

POSSIBLE NEGATIVE IMPACT IF AGENCY GOALS ARE NOT MET

GOAL 1: ENHANCE PUBLIC/OFFICER SAFETY

The inability of the department to provide a safe environment in which to travel throughout the state could result in increased numbers of traffic collisions and fatalities. These tragic events can lead to environmental impact, property damage, increased insurance premiums, and other economic losses. A reduction in officer safety places the officers in greater danger and induces financial inefficiencies through turnover.

GOAL 2: PROFESSIONAL DEVELOPMENT AND WORKFORCE PLANNING

Failing to attract, recruit, and retain a professional workforce may compromise the department's mission to provide professional services, enforce traffic laws, and save lives. If officer turnover is not reduced,

more state and taxpayer funds would be spent in an attempt to attract, hire, and retain officers. Failure to train the workforce would have a negative effect on work performance and could result in employee turnover and ineffective customer service.

GOAL 3: APPROPRIATE USE OF INFORMATION AND TECHNOLOGY

Inappropriate use of technology could result in poor customer service and higher costs to conduct business. SCDPS relies on computerized information systems to carry out its operations; report essential information; transmit sensitive information; conduct operations; and process business transactions. In addition, social media through the internet has grown increasingly important, developing into an extended information and communications infrastructure that supports the agency's service to the public.

Ineffective protection of these information systems and networks can result in a failure to deliver these vital services and disclosure of sensitive information. The department could also experience disruption of essential operations and emergency services.

GOAL 4: QUALITY CUSTOMER SERVICE DELIVERY

If SCDPS fails to adequately educate, inform, or respond to information needs of the public, the public's awareness of important traffic safety messages would be compromised.

OUTSIDE HELP NECESSARY FOR MITIGATION

The overwhelming majority of possible incidents discussed above could be mitigated with additional funding appropriated to the agency through recurring and core budget funds.


GENERAL ASSEMBLY OPTIONS

Possible options for the General Assembly to consider would be to:

- 1. Continue to evaluate funding for salary increases to assist with recruitment and retention of law enforcement officers as local agencies become more competitive.
- 2. Continue to provide the department with recurring funding for body armor and law enforcement vehicles.
- 3. Continue to provide the department with additional funding for information technology systems.

FUTURE ISSUES THAT MAY IMPACT THE AGENCY

- Officer safety continues to be a primary concern of the agency. The ongoing struggle to remain competitive with salaries offered by private sector employers and local law enforcement agencies results in reduced staffing levels, a diminishing pool of qualified applicants, decreased retention, and non-competitive law enforcement salaries; and
- Cost of leadership and employee development training.
