# **AGENCY'S DISCUSSION AND ANALYSIS**

The Public Service Commission of South Carolina (Commission or PSC) regulates the rates and services of investor-owned public utilities in the State of South Carolina and has limited jurisdiction related to the South Carolina Public Service Authority (Santee Cooper). With more than 100 years of service to the state of South Carolina, the PSC establishes just and reasonable standards for investor-owned public utilities' rates and services.

The mission of the Public Service Commission of South Carolina is to serve the public by providing open and effective regulation and adjudication of the state's public utilities, through consistent administration of the law and regulatory process. The State Regulation of Public Utilities Review Committee serves as the joint legislative committee that oversees the operations of the Commission as a result of Act 175 of 2004 and is chaired by Senator Thomas Alexander.

For the Public Service Commission of South Carolina to carry out its mission, the Commission must be alert to and anticipate emerging issues in the industries it regulates, including federal regulatory developments. Maintaining effective communications with its stakeholders aided the Commission in achieving this goal.

# **Executive Summary of Achievements**

# Strategic Goal I: Optimize Our Processes, Systems, and Decisions

- The Commission continued to review its regulations pursuant to S.C. Code Ann. Section 1-23-120(J). Final regulations for Articles 2 and 6 were filed with the General Assembly during the year. The final regulations for Articles 3, 4, 5, 7, and 8 were published in the May 24<sup>th</sup> State Register.
- In accordance with S.C. Code Ann. Section 58-37-60, the Commission conducted a proceeding for the purpose of determining whether to initiate an independent study to evaluate the integration of renewable energy and emerging technologies into the electric grid. The evidence in the case concluded this study is not necessary at this time and is not in the public interest.
- ➤ In accordance with S.C. Code Ann. Section 58-27-265, the Commission conducted a study on the electrification of the transportation sector and hosting capacity maps. A report on this matter was issued to the General Assembly's Joint Committee on Electrification of Transportation on April 4, 2024.

# Strategic Goal II: Maintain Our Commitment to the Judicial Process

- > The PSC hosted an in-house educational session from the Michigan State University Institute of Public Utilities Accounting and Ratemaking Course.
- ➤ Commissioners and Staff participated in over 683 hours of professional education.
- Annual Ethics Training was conducted in accordance with S.C. Code Ann. Section 58-3-30 (C).

# Strategic Goal III: Improve Our Operations Continuously

➤ The PSC held five meetings with its Advisory Committee to discuss its processes and procedures. Topics included the Agency's complaint form, the formal complaint process, public information notices, and minimum filing requirements for water and sewer companies.

# Strategic Goal IV: Manage Risk

- ➤ The Commission began a phishing campaign with the Department of Technology Operations. Phishing emails were sent to employees to test their recognition of a malicious email.
- ➤ Civilian Response to Active Shooter Events (CRASE) Training was held for Commissioners and Staff.

The Commission continued to improve its hearing procedures to provide the public with accessible, transparent, and effective regulation of public utilities and provide the public with clear information about the regulatory process and its decisions. To increase transparency and engagement with public utility consumers, the Commission continued the implementation of a more robust communications platform, including its SC Utility Consumer website, social media accounts, and advertisement campaign.

An ongoing goal of the Commission is to improve its operations through technological advances. As opportunities are identified, the Commission will investigate both costs and benefits before taking the appropriate actions.

As the energy sector transitions to more renewable generation, the Commission must evaluate the potential impact that these alternative generation resources may have on the reliability and resilience of the electric grid. The Commission must effectively regulate the electric industry, safeguarding ratepayers without unduly burdening the industry or stifling competition.

The public relies on the Commission's online systems to access information related to its operations. The Commission must budget funds to support maintenance and development of the systems.

The Commission's primary duty is to adjudicate cases involving the state's investor-owned utilities. This past fiscal year, the Commission opened 489 new dockets, including non-docketed items, held 51 hearings, issued 101 orders, and 781 directive orders. In 2022-2023, the PSC issued 91 orders and 726 directive orders. A total of 8,006 matters were posted on the Commission's Docket Management System (DMS). The Commission also held 40 Commission Business Meetings during the year.





The Commission's hearings encompass the electric, gas, telecommunications, transportation, water, and wastewater industries. There continues to be a steady number of filings and/or hearings within the electric industry due to the impact of ongoing issues which must be addressed from a regulatory standpoint, including the SC Energy Freedom Act of 2019. Some of these issues include demand-side management and energy efficiency programs, avoided cost methodologies and calculations, and integrated resource plans. Two electric rate cases were also filed during the fiscal year. The following charts breakdown the hearings and Allowable Ex Parte Briefings held by industry.



\*In May of 2022, the Commission ceased hearing cases involving motor carrier applications for certificates due to Act 214 of 2022.

During the fiscal year, the PSC disposed of 924 action items at the Commission's Business Meetings, and the Commission was advised of 3,524 matters. Action items are matters where the Commission makes a decision during a Commission Business Meeting. The Commission decided numerous important matters that required devotion of significant time and resources, including those in the table on the following page.







The Commission issued 141 Directives, 781 Directive Orders, and 101 Orders throughout the fiscal year. Notably, the Commission issued its orders within an average of 32.83 days between Commission Directive and Order issuance. This average accounts for a five day improvement in the time it took to issue Orders compared to fiscal year 2022-2023. The following charts breakdown this work product by industry.



The Commission continued to execute its robust digital communications program during the year to increase the transparency of the Agency's operations. This program included digital newsletters, livestreaming of Commission hearings and meetings, the use of social media, and an increased public communications plan through the Commission's SC Utility Consumer website and blog. The Commission uses the SC Utility Consumer website as a tool to increase public awareness and knowledge about the PSC's role in the community and how it serves the citizens of South Carolina. The user-friendly site educates the public on the Commission's role, services, and processes in an easily digestible format. These efforts improved the transparency of the Commission's operations.

At the start of the fiscal year, the PSC continued to use Facebook, Twitter, and LinkedIn to share information with the public. In November of 2023, the Public Service Commission made the decision to cease posting on X.com (formerly Twitter), as fluctuations in the way data was gathered on the platform and algorithmic changes made it a less useful tool than in previous years. The Commission's two Twitter accounts, @PSCofSC and @UtilityConsumer, were deleted; thus, our follower count dipped in the second half of the year, from just over 9,000 to 8,446. The Commission continues to use Facebook and is exploring new social media options in fiscal year 2024-2025.


From October 2023 to June 2024, the Commission partnered with CRANK Digital Marketing to publish and monitor Facebook advertisements for upcoming events and consumer-focused content. The total reach for this campaign was 425,677 Facebook users in South Carolina, with an average weekly reach of 30,406. As the PSC advertised solely on Facebook during the fiscal year, our audience reflected that marketing push, with over 25% of our annual traffic coming from Facebook. In addition, we can match influxes of traffic to specific dates we posted and boosted consumer-relevant ads and information.



As an example, there was a spike in traffic on the SC Utility Consumer site February as advertisements public night hearings were published. See also recurring spikes in May and June as materials related to the 821 area code overlay were published.


During the fiscal year, the Commission continued livestreaming its Commission Business Meetings, hearings, and training sessions. Statistics for the livestream are provided below. The agency's annual average of viewers, after five years of livestreaming, is 17,469. The majority of our viewers come from the PSC's website (www.psc.sc.gov), most frequently from the Livestream calendar page on the PSC site. The livestream traffic will continue to be tracked to further analyze its trends over time.

Hearings were conducted on the proposed amendments to Articles 3, 4, 5, 7, and 8 during the year.
