Explanation of Fiscal Impact

State Expenditure

This bill adds Section 61-4-945 to allow a manufacturer, brewer, importer, or retailer to offer or sponsor coupons and rebates to a consumer for the purchase of beer. Paper and electronic coupons and rebates include, but are not limited to, retailer instant redeemable coupons and mailin rebates. Manufacturer, brewer, and importer coupons and rebates must be made available upon request to a licensed retailer. A wholesaler is prohibited from participating in the procurement, redemption, or other costs associated for any coupon or rebate for beer offered or sponsored by the manufacturer, brewer, importer, or retailer. A beer manufacturer or wholesaler is prohibited from offering paper instant redeemable coupons or scan coupons for beer.
