Fiscal Impact Summary

This bill creates the "Sexual Assault Survivors' Bill of Rights Act" to provide survivors with privileged communication, access to forensic testing results, and protection from the defendant during court proceedings.

This bill does not require Judicial, the Commission on Indigent Defense, and the State Law Enforcement Division (SLED) to perform duties outside of the normal scope of business operations. As such, the bill will have no expenditure impact on either agency.

Revenue and Fiscal Affairs (RFA) anticipates that any additional local government expenditure impact will be absorbed within existing resources.

The expenditure impact is pending, contingent upon a response from the Office of the Attorney General and the Commission on Prosecution Coordination.

Explanation of Fiscal Impact

Introduced on March 23, 2021 State Expenditure

This bill enacts the "Sexual Assault Survivors' Bill of Rights Act" which defines terms, provides a survivor the right to have a victim advocate or an attorney present during a medical examination, allows privileged communications with a survivor and any person assisting the survivor to overcome the sexual assault, and allows the survivor to be reasonably protected from the defendant during court proceedings. The bill also allows the survivor to be informed of the results of forensic testing results and to have access to complete copies of all law enforcement reports concerning the sexual assault.

Judicial. This bill enacts the "Sexual Assault Survivors' Bill of Rights Act" which provides certain rights to a survivor of sexual assault. Judicial reports there is no data available to estimate the number of filings, hearings, or trials in general sessions or magistrate and municipal courts that may be impacted as a result. However, the chart below reflects the number of total filings in FY 2020-21. It is anticipated that the bill will have minimal impact on Judicial and any expenditure can be absorbed by the agency's General Fund resources.

Commission on Indigent Defense. This bill requires the agency to perform activities that will be conducted in the normal course of agency business. As a result, the bill will have no expenditure impact for the Commission on Indigent Defense.

South Carolina Law Enforcement Division. This bill requires the agency to perform activities that will be conducted in the normal course of agency business. As a result, the bill will have no expenditure impact for SLED.
