Fiscal Impact Summary

This bill requires pupils in each school district to salute the United States flag and recite the Pledge of Allegiance every school day.

This bill will have no expenditure impact on the S.C. Department of Education (SCDE) since it does not alter the responsibilities of the department.

This bill is not expected to have an expenditure impact on the state agency schools. The Governor's School for Agriculture at John de la Howe, the Governor's School for the Arts and Humanities, the Governor's School for Science and Mathematics, and the Wil Lou Gray Opportunity School indicate that this bill will have no expenditure impact, as they can manage the provisions of the bill with existing appropriations. Based upon these responses, we do not anticipate that the bill will have an expenditure impact for the School for the Deaf and the Blind.

The overall expenditure impact of this bill on the local school districts is undetermined. SCDE surveyed the seventy-two regular school districts and three charter school districts and received responses from twenty-four districts. Twenty-one of the responding districts indicate that the bill will have no expenditure impact. However, one district reports that expenses may increase if the districts are required to have a flag in every classroom, as they currently use smart boards to display a picture of the flag. The remaining three districts note that there is a potential for legal costs by requiring pupils to salute the United States flag and recite the Pledge of Allegiance.

Explanation of Fiscal Impact

Introduced on January 14, 2025 State Expenditure
